# Executive Course on LGBTQ+ Rights Law

# EXECUTIVE COURSE ON LGBTQ+ RIGHTS LAW

4-6 November 2026






## Content

This intensive course lasts three days with multiple engaging sessions each day, providing participants with an immersive exploration of various aspects of LGBTQ+ rights law.

### Key Modules:

- 1. Introduction into Human Rights Law:** A foundational overview of global human rights principles, focusing on how LGBTQ+ rights are framed within international legal contexts. Specific focus will be on the development of LGBTQ+ rights in the Netherlands, the EU and at UN level.
- 2. Artificial Intelligence (AI), Digitalisation and LGBTQ+ Rights:** A critical examination of how AI technologies and digitalisation intersect with LGBTQ+ rights, including discussions of bias, discrimination, privacy issues and ethics.
- 3. Workplace and Economics:** An analysis of LGBTQ+ rights in the workplace, covering employment law, economic inequality, and the legal protections needed to foster equality and inclusion globally for LGBTQ+ persons.

This course is tailored to **professionals (such as ERG/ Pride network members, diversity officers, policy advisors, activists, legal professionals etc.)** who are involved in developing, enforcing, or advising on policies related to diversity, equity, inclusion and antidiscrimination that require a basic understanding of LGBTQ+ rights within public and private organizations such as law firms, government ministries, NGOs, civil society organizations and other bodies. The course is also valuable to **(EUR) employees, (PhD) students, academics, and professionals in general who want to deepen their understanding of LGBTQ+ rights law** and its application in various contexts.

## Learning Outcomes

Upon completing this course, participants will:

- 1. Understand the legal framework:** Gain a comprehensive understanding of LGBTQ+ rights within the broader context of international human rights law, including key legal principles and protections.
- 2. Analyze key issues:** Develop the ability to critically analyse core issues facing the LGBTQ+ community, including discrimination, privacy rights, economic inequality, workplace rights and the role of diversity and inclusion initiatives in advancing LGBTQ+ initiatives.
- 3. Navigate legal and ethical challenges in AI:** Understand how artificial intelligence and digitalisation intersects with LGBTQ+ rights, including the potential for bias, privacy concerns, and ethical considerations in AI technologies.
- 4. Apply knowledge to the workplace:** Learn how LGBTQ+ rights are addressed in the workplace, focusing on employment law, anti-discrimination policies, and strategies to foster inclusive and economically equitable work environments.
- 5. Engage with emerging topics:** Build a foundation to engage with more advanced and evolving topics in LGBTQ+ rights law, preparing participants to stay informed and understand future legal and policy developments.

## Venue

The course takes place at Erasmus University College, housed in Rotterdam's beautifully restored former city library at **Nieuwemarkt 1A** – a historic landmark that blends rich heritage with modern academic purpose in the heart of the city. The venue is easily accessible, **located right next to Blaak station** (an around 4-minute walk).

## Lecturers

### Prof.mr.dr.drs. Jeroen Temperman

Jeroen Temperman is professor of international law at Erasmus School of Law. He is editor-in-chief of *Religion & Human Rights: An International Journal* and served on the OSCE's Panel of Experts on Freedom of Religion or Belief (2016– 2022). He holds degrees in law and humanist studies, and earned his PhD at the Irish Centre for Human Rights. He has published over 100 academic works, including *Artificial Intelligence and Human Rights* (OUP) and *Religious Hatred and International Law* (CUP), and has presented at events in over 30 countries. He has also published on LGBTQ+ rights in *Religious Speech, Hatred and LGBT Rights* (Brill).



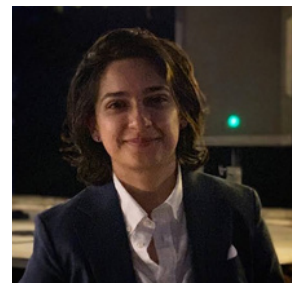
### Prof.dr.mr. Wibren van der Burg

Wibren van der Burg is professor of Legal Philosophy and Jurisprudence at Erasmus School of Law. His research focuses on three themes: methodologies of interdisciplinary legal research, legal and cultural pluralism, and the relationship between law and morality. He is co-author of *Contextualising Legal Research* (Edward Elgar, 2024) and author of *Rechtsfilosofie in een pluralistische wereld* (Boom Juridisch, 2025). Wibren has widely published on law's interaction with ethics and society, combining doctrinal, empirical, and philosophical approaches in his work and teaching. Since his dissertation in which he focused on the draft equal treatment act in the Netherlands, he has published often on same-sex marriage.



### Dr. Masuma Shahid

Masuma Shahid is assistant professor at the Erasmus School of Law, specializing in LGBTQ+ rights and the intersection of AI, queer data and LGBTQ+ rights. Masuma co-coordinates the LGBTQI+ Working Group of the Berkeley Center on Comparative Equality and Anti-Discrimination Law, is a member of the Diversity Platform at Erasmus School of Law and chairs the LGBTQ+ employee network of the EUR, QuEUR. Her research spans LGBTQ+ rights, European market and competition law, and privacy and (queer) data law. Her latest research is her PhD 'Queering Courts' on equal marriage rights before the European Court of Human Rights, the Court of Justice of the European Union and the US Supreme Court. For this, she won the 2025 Max van der Stoel Human Rights Award for the best PhD in the field of human rights in the Netherlands and Belgium.
