Transition Regulation 2022

Per September 2021 the following changes in Bachelor 3 (electives, majors) have become effective:

Senior students who have obtained a valid but insufficient result for **FEB13091-Diversity Marketing** in a previous academic year, can take examinations in this course only in block 3 and the resit period of the academic year 2022-2023.

A previously achieved result for the Diversity Marketing assignment will remain valid only in 2022-2023.

The courses Welfare Analysis and Economic Policy and Economics of Taxation have been merged into one new course Public Finance, offered in block 3.

Senior students who have obtained a valid but insufficient result for **FEB43007 Economics or Taxation** in a previous academic year, can take examinations in the substitute course Public Finance in block 3 and the resit period of the academic year 2022-2023.

Senior students who have obtained a valid but insufficient result for **FEB13101 Welfare Analysis and Economic Policy** in a previous academic year are advised to participate in the substitute course Public Finance in block 3.

Senior students who have obtained a valid but insufficient (non-compensable) result for **Philosophy of Economics** in an earlier academic year, will only have the opportunity to take examinations in this course in the academic year 2021-2022.



A previously achieved result for the philosophical essay will only remain valid in 2021-2022. Students can choose whether they want the examination to count for 100% (e.g. if they haven't written an essay before, or if they got a low grade for their essay), or if they want to enter the grade of their essay, in this case the essay counts for 30% and the examination for 70% of the final grade.

Transition Regulation 2020

As of the academic year 2020-2021, the composition of Bachelor 2 has been revised: FEB12015X-Introduction to Behavioural Economics (4 ec) has been moved to Bachelor 1. Instead of this course, the new course FEB12018X-Marketing (IBEB) (4 ec) is offered in Bachelor 2.

Senior students who have obtained an invalid or valid but insufficient (non-compensable) result for **FEB12015X-Introduction to Behavioural Economics** in an earlier academic year, still have the opportunity to take examinations in this course (both the regular examination and the resit examination) and follow the lectures and tutorials of this course in the academic year 2020-2021.

Transition Regulation 2019

As of the academic year 2019-2020, the composition of Bachelor 1 has been revised: FEB11008-Marketing (8 ec) has been replaced by FEB12015X-Introduction to Behavioural Economics (4 ec) and the new course FEB11020X-Philosophy (4 ec).

Senior students who have obtained an invalid or a valid but insufficient (non-compensable) result for **FEB11008-Marketing** in an earlier academic year, only have the possibility to take examinations in this course (both the regular examination and the resit examination) in the academic year 2019-2020. Already obtained results for the assignments, the marketing plan and the interim test remain valid in 2019-2020 only.

NB For senior students, the Bachelor's programme remains unchanged; senior students follow FEB12015X-Introduction to Behavioural Economics in Bachelor 2 and FEB12002X-Philosophy of Economics in Bachelor-3.

Transition Regulation 2018

Majors

As of the academic year 2018-2019, the composition of the Majors has been revised.

Students who have started a Major in an earlier academic year, may still complete this Major in the old composition of the academic year 2017-2018 or earlier. This also applies to the **Major Accounting and Finance** which is no longer offered as of the academic year 2018-2019.

Bachelor's thesis

Students who have started a Major in an earlier academic year are not required to write the Bachelor's thesis on a subject from this Major.

Transition Regulation 2014

Transition Regulation 2007

General

IBEB students who would like to finish their bachelor-1 or bachelor-3 programme can make use of the Transition Regulation below.

N.B. It's not possible anymore to take examinations as stated in the 'old' programme. Students who still have to complete 'old' courses, have to follow the corresponding 'new' courses within the *Jaarplansysteem* and therefore also have to attend the obligatory practicals.

IBEB-3

The Transition Regulation requires that a combination of a seminar and the Bachelor's thesis adds up to 20 cr (the combination of an 'old' seminar of 10 cr and a 'new' Bachelor's thesis of 8 cr is not allowed). Because of the formal rule of 180 cr for completing your Bachelor's degree programme, it may be necessary to complete your Bachelor's thesis with the 'old' student workload of 10 credits. If the total amount of credits for the bachelor-3 programme adds up to 58 of 59 credits (e.g. if some courses with the new student workload of 4 credits were followed), students can send a written request to the Examination Board for dispensation for the one or two credits that are missing. If, at the end of bachelor-3, students miss more than 2 credits, they will have to choose an extra elective.

Course codes

As a result of the introduction of the Jaarplansysteem the old course codes (capital letters FEW + four figures) were per 1 September 2007 replaced by new course codes (capital letters FEB or FEM + a new combination of figure/letter).

Old courses that were last offered in the academic year 2007-2008 keep the old FEW code.
