## The Rule of Law and Private Power

Webinar Series September – December 2021

References to the 'rule of law' as a desired component – and even a telos – of systems of social organization point to the need to prevent arbitrariness in the exercise of power. Instead, power needs to be controlled, its exercise anticipated and justified on the basis of general rules. Going beyond a conceptualization that confines the ambit of the rule of law to the state and its exercise of public power, the Webinar Series will inquire about the relevance of the rule of law framework for the exercise of *private power* – focusing in particular on transnational corporate actors. On the one hand, the rule of law could constitute an ideal that promises the regulation of such power and the protection of those who are subjected to it from its arbitrary exercise. On the other hand, as recent Law and Political Economy scholarship has highlighted, private power is itself, at least partially, a product of legal entitlements. From this perspective, private power is constituted by the rule of law in the first place, the function of which is to ensure predictability of outcomes and the smooth operation of markets.

Exploring this dualism further, some of the questions that will be addressed by the speakers of the Webinar Series, across different subfields of legal inquiry, include: How does law generate private power? Through which prohibitions or permissions does the (international) legal infrastructure create and sustain asymmetries of power that result in socio-economic inequalities? Does globalization and the emergence of global private powers entail a paradigm shift with regards to both the origins and the possibilities to restrain private power? Do voluntary forms of social engagement with public goals (e.g., Corporate Social Responsibility) blur the public/private divide? Can the rule of law harbour institutional imagination or does it only guarantee the perpetuity of existing forms of social organization? What is the relationship between the rule of law and normative visions of sustainable, equitable, and democratic global political economy?
