1. Level 1:

Contracts with a commitment for EUR lower than and/or equal to \leq 250.000 (including VAT) per calendar year and only for four years or less than four (4) years must be signed by the Dean of the responsible Faculty or the Rector of the responsible Institute.

2. Level 2:

Contracts with a commitment for EUR exceeding € 250.000 (including VAT) per calendar year and/or longer than four (4) years will be signed by the President Ad Interim of the Executive Board EUR: H.N.J. Smits, the Rector Magnificus of the Executive Board EUR: prof. R.C.M.E. Engels, or the Secretary General of the Executive Board EUR: A.M. O'Brien.
