

Requirements for EUR-students

IBA courses are only available for students who are currently enrolled in an English-taught Bachelor programme from a Dutch research university and who meet the general admission requirements for the BSc IBA programme (please refer to the overall grade, mathematics, and English requirements on the www.rsm.nl/bsciba site). If you do not meet the requirements or if you have not been granted permission to follow a course due to capacity restrictions you will be notified by email.

Please note: it is only possible to follow elective courses free of charge if you have not previously obtained a Bachelor's degree. More information can be found [here](#).

Deadline application

To prevent delays, your registration must be processed before the course starts.

The following electives are now available:

- Block 3 and block 7 = start 11 January 2021. **Application deadline: 13 December 2020**
- Trimester 8 = start 4 January 2021. **Application deadline: 13 December 2020**

Due to the current COVID-19 situation we are not able to inform you about the rest of the elective courses yet. More information will follow at the end of February 2021.

Application procedure

Register for an elective course via the registration form (at the bottom of this document) and email this form to bsc.pm@rsm.nl.

When returning the registration form you must include the following documents:

- Statement from your programme's Examination Board granting you permission to follow the courses of International Business Administration as an elective course;
- Proof of mathematics proficiency;
- Official transcript indicating the number of completed EC (grade list) at your programme.

You will receive a message from BSc Programme Management about your placement as soon as possible via an admission letter per e-mail.

Please note that EUR-student do **not** need to register via Studielink to follow elective courses at the EUR.

*IBCoM-students do **not** need to fill out this form and should directly contact their Programme Coordinator at ESHCC to follow elective courses at RSM.
