### DISABILITIES & ACCESSIBILITY

Struggles for the inclusion of, among others, people with disabilities demand a rich scope of strategies and tools. Discussants in this panel show how VR, AI, social media, as well as specific policies and projects can help secure fair accessibility to key social spheres and resources like education, work, cultural heritage, media representation and neuro-medical attention. However, they also warn us about persisting risks and biases and thus about the need for continuous critical reflection.
