"There are courses about carriage and goods, or charter parties. In other words: about the contractual sides of maritime and transport law. How to draw up the contractual documents used in the operation of ships and the carriage of goods by sea? Also

interesting is the course about incidents and accidents in the transportation. What if an oil tanker sinks? What if a container with cargo explodes in the middle of the ocean and the ship needs to be saved from that? Then there are the courses Law of the sea, on the public law side, and Marine Insurance, about keeping the financial risks under control. Subjects are considered from a comparative law perspective. Many alumni have found jobs in the maritime industry. Most of them are working for underwriters, because a lot of the work is actually done by them. You might become a lawyer, a business lawyer, or maybe join us academics."
