Terms and conditions

These terms and conditions apply to the Conditional Offer which a student may receive for International Bachelor Economics and Business Economics 2026-2027 offered by Erasmus School of Economics. By accepting the offer in Studielink, the student agrees to these terms and conditions and declares to understand and take responsibility for the following subjects:

Start academic year

You declare to be present at the start of the academic year on **Monday August 31, 2026.** The academic year will start with a Take-Off Day. You will receive more detailed information about the Take-Off programme during the month of August.

Finalizing the application

You commit to supply Erasmus School of Economics with certified copies of your diploma and your final grade list before **1 August 2026** ((I)GCE A-level and Irish Leaving Certificate students know an extended deadline of **21** August). If the application file is not complete before this date, the Conditional Offer expires and the request for enrolment will be cancelled in Studielink. The University expects each applicant to obtain final grades in line with the grades shown in the application documents and therefore could question your final grades should these differ from the grades on the moment you submitted your application. Final grades have influence on whether your diploma is accepted for admission to a Dutch Research University. It is therefore advised for each student to aim for a positive final grade list. Any student is obliged to inform the University when there is a change in the final examination curriculum with regards to the chosen courses as well as the level at which the course will be examined.

Housing

Erasmus School of Economics does not offer any housing itself. You may find housing through the options mentioned in the housing section on the new students website. You declare that, if an agreement with any housing corporation is made, you are responsible for the costs of rent, even if you do not start your studies in 2026. You are aware that the Erasmus School of Economics is not an intermediary in this process.

Visa and/or residence permit (only applicable for non-EEA students)

If you require a visa and/or residence permit, the University must participate in this procedure for you since the procedure is based on your studies at our University. The window for the University to start an immigration procedure runs from April until 30 June (15:00 CET). If this situation applies to you, you are obliged to send in all required visa application documents and to transfer the annual tuition fee, deposit for living expenses for an entire year and the costs for starting the immigration procedure, to the Erasmus School of Economics' bank account prior to the deadline of 10 July.

The costs of living are set to be 1.115 euro per month. This implies that each non-European bachelor student is to make a deposit of 13.380 euro + payment of the annual tuition fees in order to prove to the Dutch immigration services that you can study in our country without financial difficulties. This 13.380 euro is only a deposit and will be reimbursed to you after you have obtained a Dutch bank account at the start of your studies. Costs* for starting the immigration procedure are 243 euro and are non-refundable.

If you fail to send in the required visa application documents and/or to transfer the required funds before the above-mentioned deadline, it is no longer possible to apply for a visa and/or residence permit. As a result, the Conditional Offer will expire. Erasmus School of Economics points out that with only a student visa and/or residence permit your Conditional Offer can result in an enrolment.

Since the window for the University to start an immigration procedure runs from April until 30 June, applications of non-EEA students who are still on the waiting list will be withdrawn in July
