Study in the Netherlands

Welcome!

You probably know the Netherlands for its tulips (everywhere in spring) and its wooden shoes (rare). The Netherlands has around 17 million inhabitants, but it's a small country. Yet, it has one of the most important and most innovative economies worldwide. Many internationals say the Netherlands is a well-organised country with open-minded people. Most of the country's 35,000 kilometres of bicycle paths are in the province of South Holland, where Rotterdam is.

And nice to know: in the Netherlands, you don't have to speak Dutch to do your groceries or order drinks, most people will switch to English for you.

Why study in the Netherlands?

Dutch education is known for its high quality and standards, and top-ranking positions. Degrees obtained in the Netherlands are internationally recognised. The Netherlands is one of the top providers of English-taught courses. Our international classroom - a mix of international and Dutch students - is common across the university.

In class, the atmosphere is usually informal, and it is pretty easy to speak to our professors directly. The Netherlands is known as easy-going, liberal and tolerant - ideal for students. Studies in the Netherlands are affordable and accessible, for European and non-European students.



Life in Rotterdam

Student city

Rotterdam is the country's second largest city. The largest port of Europe, and a cosmopolitan city in one. In addition to the city's vibrant hospitality scene, there are plenty of student activities. You can join the Erasmus Student Network (ESN), which organises lots of social programmes, trips, interesting debates and cultural events, on and off campus. With a party now and then, of course.

Multicultural city

The inhabitants of Rotterdam have diverse backgrounds. This melting pot of nationalities and cultures makes Rotterdam an interesting city where you will soon feel at home. You can feel the international atmosphere on the streets while shopping at a Turkish bakery or an Indonesian toko. In Rotterdam, no one is a stranger.

City career perspectives

Rotterdam hosts many multinational organisations. You might get to know your future employer during your studies, for example by doing an internship. A good proficiency of English is required, and we recommend learning some Dutch as well to increase your chances in the competitive market for talent.

IBA in practice

Career outlook

The Bachelor of Science in International Business Administration prepares you for a management career in international firms by teaching you the latest knowledge and skills in business, and through immersion in an intercultural classroom. Most students specialise in one of the main functions of business: production, organisation, marketing or finance, and your first job will probably be within one of these business areas.

Of course a company is more than a sum of specialisms. Future managers also need to develop a broader perspective. This is where strategy comes in. Working in culturally diverse teams familiarises IBA students with multinational project management at an early stage, qualifying you for jobs in the international arena.

Challenges for managers

Management requires a broad overview of what's going on, as well as thorough knowledge of the various functions that make a business. Managers can achieve senior positions when they learn how to consider different views and to apply knowledge from various fields.

A profitable and sustainable company, gaining in market share, is the ultimate goal. There are many ways to get there. Will you keep costs at bay? Will competitors undercut your price? How will you guard intellectual property? What is your

marketing strategy? And what about your people? Diversity fosters creative thinking, but not necessarily a harmonious office. Also, will your activities be sustainable?

Business flourishes when managers balance all these elements. Are you up for the challenge?

Strategic business plan

The strategic business plan is a valuable tool for business-oriented activities. In the IBA, you set out to position a company or project in its commercial ecosystem. With your team, you'll gather the required information, meet with knowledgeable experts and apply the theoretical concepts you acquired during your studies. Identify strengths, weaknesses, opportunities and threats. Based on your findings, you'll formulate the best possible strategies for your undertaking.

The curriculum

RSM's International Business Administration (IBA) programme takes a broad approach, yet offers differentiation as well.

The research-oriented approach is reflected in a track of research courses throughout the entire programme. Your professional development will be stimulated in a similar track. For most courses, you will attend plenary lectures and work in small groups, allowing for lively interaction and tailored feedback. Many courses have a distinctly international approach, content-wise, and by valuing the diversity within the IBA student body.

First year

The first year of the IBA bachelor programme consists of four blocks, and provides you with an overview of the main processes in most companies: production, marketing, organisation, finance and information. And, you will benefit from our student mentor programme, designed to help you get used to student life at Erasmus University Rotterdam.

Binding study advice

By the end of the first academic year, you must have successfully passed all your first-year courses. Otherwise you will receive a negative 'binding study advice'. We have set up the IBA programme in such a way that your performance in all courses will be appraised at frequent intervals, enabling you to earn a considerable part of your credits before the final exams.

Second year

The second year of the IBA programme also consists of four blocks, but courses such as the research project or entrepreneurship will stretch over a longer time. In the Professional Development track, you will further enhance your personal skills. The increasing importance of contributing to sustainable business is reflected in the 'Responsible business & leadership' course.

Third year

In the first half of the third year, you can choose to do an international exchange, an internship or a minor. In the second half of year 3 you can pick one out of five tracks, allowing you to follow your interests and also to prepare for a master. Finally, you will also write your bachelor thesis in the field of one of these tracks:

- Model builders (data, operations)
- Performance analysts (finance, accounting)
- People experts (marketing, diversity, behaviour)
- System thinkers (international business, strategy)
- Change agents (entrepreneurship, innovation)

How to make the most of your studies

Study abroad

One of the many benefits of the programme is the possibility of studying abroad at some point. RSM offers a wide and attractive network of around 100 partner business schools for its bachelor exchanges, see pages 14-15.

International internship

An international internship is an alternative to an exchange. You can apply your newly acquired knowledge and skills within a company in another country. Many students are offered a job as a result.

Sandwich track and add-on track

The 'sandwich track' enables you to include an additional year of studies between your second and third year. The 'add-on track' is an extension of your studies by adding an additional year after the third year. This year strengthens your professional profile, and will give you an asset when applying for a job after your bachelor.

Honours programmes

Erasmus University Rotterdam offers two English-taught honours programmes on interdisciplinary subjects. They bring students from various programmes together to jointly work on a broad subject. And, IBA students can also apply for RSM's undergraduate honours programme on innovative entrepreneurship and a study trip to Silicon Valley. Honours programmes count as extra credit on top of the regular BSc programme.

Study trips, business projects, case competitions

Another way to gain relevant international experience is by joining one of our international study trips. Our international business projects take a more academic approach; desk and field research are done for commercial businesses and are supervised by RSM's academic staff.

Alternatively, some IBA students are involved in international non-profit organisations such as Enactus, which focuses on sustainable entrepreneurship. You can also join RSM STAR Case Society. You can then be selected for international case competitions, in which teams of four from business schools worldwide compete to solve challenging business cases.

Study counselling

Balancing studies and other activities can be a challenge. Many students appreciate our mentor programme. It assigns freshmen to second-year students to help them find their way at the university and in Rotterdam: how to study and how to plan ahead. More personal matters are swiftly referred to trained student advisors.

RSM also proudly offers the MSc in International Management/CEMS (18 months), a joint programme by several leading business schools around the world which has a broad remit and requires the mastery of three languages. CEMS has been ranked one of the world's best business programmes by Financial Times for seven consecutive years.

Career opportunities

Some IBA graduates walk straight into a career or set up their own company, but most continue with a master programme first, because this improves their career prospects. Sometimes, large multinational firms hire master graduates prior to graduation, based on internships and other networking experiences. The main employment sectors and the percentages of IBA graduates entering each are as follows: consulting (20%), finance and accounting (20%), marketing and communications (15%), owner-entrepreneur (10%), human resources (10%), policy advising (5%), and other business areas (20%). Our career services team can assist you in finding internships and with around 40,000 alumni in more than 100 countries, RSM's alumni network is truly global, and provides valuable mentoring, job and internship opportunities.

"I started my IBA studies at RSM in 2009 and was determined to make it an international experience. So I took my chance to go on exchange in South Korea. I then really wanted to work abroad. So after finishing my master in Finance & Investments at RSM I started to work as a trainee at STAR Capital in London, UK. Then I completed an MBA in Tel Aviv, and returned to London for a career in finance. Two long internships - at UBS on real estate and at Greenfield Capital on private equity - brought me

where I wanted to be: at Macquarie Capital in investment banking, first as an analyst and now as an associate. My focus is on principal investments in infrastructure in the Benelux. In retrospect, I found myself privileged - because of the choice of options I was offered inside and outside studies. As I am aware that this is not a given for all, I have decided to set up a scholarship system together with some classmates, in order to make this wealth of chances also available for others".

Admission

Admission requirements

To be considered for the IBA programme you need a secondary school diploma which gives you access to university-level education in your own country and is deemed equivalent to the Dutch secondary school diploma. You must also meet the following additional requirements:

- you should have passed mathematics at least at calculus level
- you must have a sufficient result for TOEFL or IELTS (English-language tests).

When to apply? Strict deadline!

You must apply through the Dutch national student registration system 'Studielink' between October 2019 (once Studielink opens) and 15 January 2020.

Numerus fixus

RSM's IBA admits a maximum of 650 students each year. Important characteristics of the IBA programme are its international dimension and high-performing students. Admission to the IBA programme is therefore based on your academic performance as reflected by your overall grade point average and your motivation for the international character of the programme as reflected in your CV and your answer to the motivation question.

Here's how we'll calculate your ranking:

- Your GPA, as this will be calculated from your school report using unrounded grades of the before-last school year, counts for 75 per cent of your total score. The higher your grades, the more points you get. More details can be found on the page 'admission criteria per diploma' on our website.
- Your CV or your answer to the motivation question counts for 25 per cent of your total score, and should give us sufficient insight in your international background and experiences.

The application process consists of two parts:

Part I: registration for the IBA programme in the Dutch national student registration system Studielink (**www.studielink.nl**) between October 2019 (once Studielink opens) and 15 January 2020.

Part II: fill in and submit RSM's Online Application Form (OLAF). You will receive a link to this form within 24 hours after successful registration in Studielink.

Before 31 January 2020, you must:

- upload all the required documents and submit your application.

All applicants who submitted a complete application in OLAF on time will receive a rank number via email from Studielink on 15 April 2020. Applicants with rank number 1 to 650 will also receive a second email from Studielink with an offer for the programme. Applicants with rank number 651 and higher will automatically be put on a waiting list. Applicants offered admission to the IBA programme (initially or from the waiting list) will have two weeks to accept or decline the offer in Studielink. Prepare for your studies

How to prepare?

Once you have decided on a study programme, you need to prepare. The process starts with your admission application. Then you might need a visa or residence permit, and find a place to stay in Rotterdam.

Tuition fees

The 2020-2021 tuition fee for the IBA programme is €9,300 per year. The Dutch government contributes towards this cost for students who hold nationality from a country belonging to the European Economic Area (EEA). These students therefore pay the statutory fee of €2,090* per year, with a 50 per cent reduction for year one.

Accommodation

There are several ways to find suitable accommodation for the first year of your studies at RSM. Once you have been accepted into the IBA programme, we will give you the information you need to start your search for a place to live. Early applicants will find it easier to obtain housing than those who apply late. Latecomers may not find a place in time for the start of the programme, so please apply as early as you can. From mid-April onwards you can register for a room ("reserved accommodation") via the housing agency SSH, and from mid-May onwards you can register for an on-campus room via Xior. Rooms are limited, and registrations will be approved on a first come, first serve basis. For more information, visit

Costs of living

The costs of living and studying in the Netherlands are around €900 a month. You need this to cover daily expenses such as rent, groceries, books and going out. A part-time job can be a source of additional income but do be advised that studying will take a lot of your time. International students need to remember that they cannot rely on an additional income once they are in the Netherlands. Non-EEA students in particular should be aware that the number of hours they are allowed to work in a paid job are limited. Make sure that you have sufficient financial means before coming to Rotterdam.

Study grant

As a rule, Dutch students will receive a government funded study grant that comes as a loan. The Dutch study grant is also available under the same conditions to students from EEA countries, but only if the student, or their partner or parents have a paid job in the Netherlands for at least 14 hours per week. EEA students can also apply for so-called collegegeldkrediet, which is an advance on tuition. Moreover, EEA students can also apply for a supplementary grant, depending on parental income. Please visit **www.duo.nl** for more information.

* The statutory fee is subject to change. Prior to the start of the academic year, tuition fees may be modified by the Dutch government. Scholarships

Especially for non-EEA students, who pay the nonsubsidised tuition fee, RSM offers a few merit-based scholarships. RSM also offers an interesting scholarship for students with an EEA nationality. Immigration procedure

Whether or not you need an entry visa or residence permit to study in the Netherlands depends on your nationality.

- If you are from the EEA, then you can easily take up residency in the Netherlands and do not need a residence permit.
- If you are from the USA, Canada, Japan, New Zealand, Monaco, South Korea or Australia, you do not need an entry visa for the Netherlands, only a residence permit for the duration of your study (three years plus three months).
- If you are from any other country, you need an entry visa for entering the Netherlands, and a residence permit for the duration of your study (three years plus three months).
- If you already have a Dutch Residence Permit, RSM/EUR will send you the appropriate information.

As soon as you are admitted to the programme (conditionally or unconditionally), RSM/EUR will send you the immigration guidelines. Please do not start the immigration procedure on your own, only RSM/EUR can apply on your behalf. More information can be found at **www.rsm.nl/immigration**.
