The Erasmus Initiative Dynamics of Inclusive Prosperity (**Do IP!**) at Erasmus University will stage a major two-day event on November 29-30, 2018, in Rotterdam, in close cooperation with Royal Philips and World Economic Forum. Parallel and connected to the academic and business conference we offer business startups/scale-ups and young academic standups a podium to meet our event guests and pitch their business or project by way of posters and/or multimedia presentations on the first conference day. The jury will comprise a representation of the **Do IP!** academic team, the main sponsors and the keynote speakers and will judge the projects on their potential for fostering sustainable business and inclusive prosperity.

On Thursday 29 November, the first day of the conference will offer key notes from renowned speakers and multiple 'mix & match' events for bringing together leaders from the worlds of business, government, NGO and academia to discuss the transition towards more responsive and responsible leadership. This is a public conference, co-hosted by WEF and Philips, taking place at the Rotterdam Hilton in the inner city area. On Friday 30 November, the research agenda and scientific results will be the focus during the scientific conference that will take place at the Woudestein Campus of Erasmus University Rotterdam.
