Criteria for proof of financial means – Change of Purpose, Switching Institutions or Residence permit extension

International students who study in the Netherlands must demonstrate that they have sufficient financial means available to cover their living expenses during their stay. These criteria are set by the Dutch Immigration and Naturalisation Services (IND) and need to be strictly observed. Which specific documents should be submitted depends on your personal situation.

Please note:

- You must demonstrate to have available at least <u>€875</u> for each month of study at EUR (= €10.500 for a full academic year). This amount is the minimum amount required for living expenses only, excluding tuition fees and immigration fees. If you are going to study at EUR for more than one year, you will have to provide proof of solvency for the initial twelve months.
- Certificates of deposit are never accepted as proof of sufficient financial means, unless they explicitly state that the amount is freely available at all times

Possible scenarios:

- A. You submit proof that you have sufficient funding available in your own bank account;
- B. You demonstrate that you have a sponsor located outside of the Netherlands:
- C. You demonstrate you have a sponsor located in the Netherlands;
- D. You demonstrate that you are sponsored by a company
- E. You demonstrate that you receive a scholarship for studying at Erasmus University Rotterdam

A. You submit proof that you have sufficient funding available in your own bank account (see appendix b. for a format)

If you have the required amount available in your own bank account, you can demonstrate your financial means by providing us with an **original bank statement** of your account. Please ensure that it meets all of the following conditions:

the bank statement must be original, printed on the bank's letterhead paper and contain a
stamp and signature of an authorized bank employee;
the bank statement must be wholly or partly in your name;
the statement must be recent (it may not be issued more than 2 months ago);
the date of the statement must be shown;
your name, initials and address must be on the statement;
the account number and type of account must be indicated;
the bank balance must be shown and the amount must be sufficient for the duration of your studies;
the bank's contact details must be on the statement
if it does not concern a current account or regular savings account, the statement must explicitly mention that the amount is available for withdrawal at all times.

Please note that **certificates of deposit** are never accepted as proof of sufficient financial means, unless they explicitly state that the amount is freely available at all times



Amounts should preferably be stated in euros, but other currencies will be accepted as well.

B. You demonstrate that you have a sponsor located outside of the Netherlands

If you are financially supported by an **individual** (e.g. a parent or family member) living outside of the Netherlands, we will need the following documents:

A: Original declaration of financial support (to be downloaded from the IND website)

B. Copy of your sponsor's proof of identity

C. You demonstrate you have a sponsor located in the Netherlands

When does someone living in the Netherlands qualify as a financial sponsor?

A person in the Netherlands who pays part of the study and residence costs for a student should have an income that meets the standards laid down in the Work and Social Assistance Act (WWB) plus the amount that that he/she as financial sponsor wishes to contribute. Which WWB standard the sponsor has to comply with depends on their family situation. The current standard for the WWB is stated on the IND's website. If the sponsor is married, or in a registered partnership, the partner's income may be included. The partner will need to provide the same documents for proof of income as the main sponsor and these must be included with the application. For both full and partial financial assistance, an individual student may only have one private sponsor in the Netherlands.



If you are financially supported by an **individual** (e.g. a parent or family member) living in the Netherlands, we will need the following documents:

If a person employed by a company in the Netherlands supports you financially we need:

A: Original declaration of financial support (to be downloaded from the IND website)

B: Original 'extract' from the municipal administrative records (GBA)

To determine the financial sponsor's family situation, an excerpt from the official municipal administrative records (a GBA extract) must be provided. The sponsor's family situation must be shown in this document.

C: Copy of contract of employment

If you are supported by someone who has an income in the Netherlands from working on a self-employed basis we need:



A: Original declaration of financial support (to be downloaded from the IND website)

B: Original Extract from the municipal administrative records (GBA)

To determine the financial sponsor's family situation, an extract from the official municipal administrative records (a GBA extract) must be provided. The sponsor's family situation must be shown in this document.

C: A copy of the Chamber of Commerce Extract

This must be recent extract (no more than 2 months old) from the Chamber of Commerce relating to the sponsor's company/business.

D: Original fully completed income statement self –employed individual (form M57)

A standard declaration can be requested from EUR's immigration desk (visa@eur.nl)

E: Copy of Provisional Tax Assessment IB/IB60 from the previous year

The financial sponsor must provide their provisional tax assessment IB/IB60 from the previous year.

D. You demonstrate that you are sponsored by a company

If you are financially supported by a **company**, we need the following documents:

A: Original declaration of financial support (to be downloaded from the IND website)

B. A statement from the company indication that the person signing the declaration is authorised to do so.

C. Copy of proof of identity of person signing the declaration

If you are unsure if the scholarship award letter includes all required details, we strongly advise you to ask your scholarship provider to complete a scholarship certificate as additional proof (see appendix a.).
