### **JOB DESCRIPTION**

As Postdoc researcher you will work on a number of Health Technology Assessment (HTA) projects. You will be further involved in methodological research of quality-of-life measurements, the preparation of HTA studies, and economic evaluation calculations. Furthermore, you will write and publish papers.

In addition, the candidate should possess strong communicative skills in both Dutch and English, have strong organizational skills and be able to keep to deadlines. The candidate should be proactive, be able to work independently as well as in a team. The candidate will collaborate with researchers and clinicians from the department of Public Health and clinical departments.

Being able to present a certificate of good conduct is a condition for the appointment.

### **TERMS OF EMPLOYMENT**

We offer a temporary contract of one year with a possibility of an extension, based on performance. The gross monthly salary amounts a maximum of € 4.842,- (scale 11), depending on your level of education and relevant experience and based on a full-time working week of 36 hours.
