Maximum budget for master courses

Last year ESE decided to limit the budget that departments receive for their master courses. The budget depends on the number of so-called dbu (docent belastinguren), i.e. the lecturer's workload for the whole course, expressed in hours. The workload of a master course is calculated by multiplying the number of credits (4 for the master courses) by the number of successful students (= those who passed the exam at the end of the course).

The maximum number of dbu for which a budget will be granted is now limited to 300. That means that the budget for 75 successful students (300 dbu) will be exactly the same as the budget for 100, 150 or more successful students. However, with 50 students the budget will be lower (200 dbu).
